This Memorandum of Agreement is entered into by and between GRAND HARBOR MARINA, INC., a Florida corporation and GRAND HARBOR DOCKMASTER, INC., a Florida corporation and their successors and assigns (collectively "Seller") and 32967 PARTNERS, LTD., a Florida limited partnership and its successors and assigns as the owner of the Property, as hereinafter defined ("Buyer") and joined in by GHA GRAND HARBOR, LTD., a Florida limited partnership and GRAND HARBOR GOLF & BEACH CLUB, INC., a Florida corporation (collectively "Grand Harbor Club Entities").

WHEREAS, Seller and 31 Kings, Corp., a Florida corporation ("31 Kings") entered into that certain Contract for Sale and Purchase dated February 26, 2004 (the "Agreement"), the subject matter of which is certain real property located in Indian River County, Florida, as more particularly described on <a href="Exhibit "A", attached hereto and made a part hereof (the "Property"); and

WHEREAS, 31 Kings assigned all of its right, title and interest in and to the Agreement to the Buyer pursuant to an assignment dated even date herewith; and

WHEREAS, Seller and Buyer and the Grand Harbor Club Entities have agreed to record this Memorandum of Agreement in order to provide third parties with notice in the Public Records of Indian River County, Florida, of the existence of the Agreement as it pertains to the real property owned by the Grand Harbor Club Entities, as more particularly described on Exhibit "B", attached hereto and made a part hereof (the "Club Property").

NOW THEREFORE, in consideration of the sum of Ten and No/100 Dollars (\$10.00) and other good and valuable consideration, the parties agree as follows:

- 1. The parties have entered into the Agreement with respect to the Property as of the date set forth above.
- 2. Pursuant to the terms of Paragraph 37T of the Agreement, Seller and the Grand Harbor Club Entities have issued to Buyer thirty (30) non-equity club use privileges in Grand Harbor Golf & Beach Club (the "Marina Privileges"). The Marina Privileges provided to Buyer will have the same use privileges and dues amounts (but are only paid during the period such privileges are activated and used by the owner of the Property or assigned to a user for the period of such assignment) as social memberships

in the Grand Harbor Golf & Beach Club and any amendments to the provisions related to social memberships shall not be discriminatorily applied in any adverse manner to the Marina Privileges. The terms and provisions establishing the Marina Privileges and the conditions upon which they may be utilized are more particularly set forth in Paragraph 37T. of the Agreement.

- 3. This Memorandum of Agreement is being recorded in the Public Records of Indian River County, Florida, to place third parties on notice of the existence of the Agreement with respect to the Club Property.
- 4. This Memorandum of Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same Assignment.
